

CONSENT

to Receive Informational Communications and Marketing Notifications and to the Processing of Personal Data for Commercial Purposes

I hereby confirm that I wish to receive company news, service notifications, and marketing, advertising and informational communications (hereinafter referred to as the “Informational Materials”) from Pascal Trading Limited / 帕斯卡貿易有限公司, Company Registration Number (CR No.): 80236786, Business Registration Number (BR No.): 80236786-000-04-26-9, registered address: RM11, 13/F, BLK C WONG KING IND. BLD., 192-198 CHOI HUNG RD SAN PO KONG HONG KONG (hereinafter referred to as the “Operator”).

By activating the interactive checkbox next to the text “By clicking the ‘Subscribe’ button, I consent to receiving communications and to the processing of personal data”, I agree that the Informational Materials may be sent to me via:

- SMS messages;
- Messenger messages;
- Telephone calls;
- Email messages.

For the purpose of sending me Informational Materials and notifications regarding updates to the Operator’s IT interfaces and services, I consent to the Operator processing the following personal data:

- Name;
- Email address;
- Telephone number.

I agree that my personal data may be processed by the following means: collection, accumulation, storage, alteration, supplementation, use, blocking and destruction of data, as well as cross-border transfer to foreign countries that ensure an adequate level of personal data protection in accordance with the Personal Data (Privacy) Ordinance (PDPO) of Hong Kong.

Since the digital service and related informational and technical services described on the Operator’s Website may be provided in cooperation with the Operator’s regional technology partners, I agree that my personal data may be provided to such partners for the purpose of achieving the stated purpose of processing.

By giving the Operator my consent to the processing of my personal data, I confirm that I have read the terms of the Privacy Policy and do not object to the processing of my data within the framework of the stated cooperation.

In turn, the Operator guarantees that it will not transfer personal data to third parties that do not require such data for the stated purposes. The Operator also guarantees that the processing of personal data will be limited to achieving specific, predetermined and lawful purposes, and that the content and scope of the data processed will strictly correspond to the stated marketing and informational purposes. Personal data collected for communications purposes shall not be made available through publicly accessible sources.

The processing of my personal data may be carried out using automated means or without the use of automated means (mixed processing).

This consent shall remain valid until the purpose of processing has been achieved or until the data subject withdraws consent to receive Informational Materials.

I may withdraw from receiving communications and from the processing of my personal data for this purpose at any time. To do so, I may:

1. Withdraw my consent to the processing of my personal data for commercial and advertising purposes by sending a free-form request to help@osago.hk from the email address to which the materials are sent;

2. Follow the interactive “Unsubscribe” link at the bottom of any email from the Operator and confirm my decision to unsubscribe.

In any of the above cases, the Operator undertakes to immediately cease sending Informational Materials to me and to cease processing my personal data for this purpose.
